Building Permits:

Endres Farms: Andrew Endres was present at the August 19, 2013 Planning Commission Meeting with a permit application for an auxiliary building. 900 sq ft, 30x30, located on Cty Rd 86 (280th Street). The building meets all setbacks and is zoned agricultural. Electrical will be installed, but no running water, so septic is not an issue.
